In accordance with the recorded Covenants, Conditions and Restrictions of the Association, it is required that any lot owner must submit the following to the Architectural Review Committee prior to initiating work on the planned improvements: All CCR information is located on the Lantana Ridge Website

1. **Completed Improvement Request Form, including appropriate attachment A, B or C**
2. **Complete a detailed building plan, project plan and specifications for improvement**
3. **Include a rendering, pictures and or samples pictures of project materials for project**
4. **A site plan showing the location of the proposed improvement in relation to lot lines on the property.**
5. **Improvement request are required for any exterior project that changes the appearance of the property.**
6. **Once project is approved by ARC it is required that an "ARC approved Project" sign be placed at front of property. An ACC representative will make contact.**

If any improvement is made without prior ARC approval, the Association has the authority to require the owner to remove the improvement from his/her property. Any owner considering any improvement to his/her property is urged to review the recorded deed restrictions prior to submitting a request.

Example, missing information, waiting on response from you or builder etc. understand that the Architectural Review Committee will act on this request within twenty one (21) days of receipt and contact you in writing regarding their decision. I agree not to begin construction of improvements without written approval from the Architectural Review Committee.
